PRESIDENT'S MESSAGE: J.D. Boydstun



Dear DCV Members and Friends,

Lately I have been involved in an ongoing battle of facts and ideas on the editorial pages of my local newspaper. As a rule I seldom respond to essays or editorials due to their extremely vapid content, but lately I have been very much involved with those people who love to call Southerners of the Secessionist Era "traitors". I would like to offer you a way to counter the argument that Southerners are traitors which is so prevalent in contemporary thinking. I have found it to be very powerful because it is true.

Here are the facts: in order to commit treason against the United States, one must be a citizen of the United States. Their entire argument for treason rests on the highly tenuous premise that in the years 1860 and 1861 the act of secession was somehow, someway prohibited by the U.S. Constitution. The truth is there was no bar to secession at that time. It does not matter if they disagree, it does not matter if they do not like it, there was no bar to secession. So when the Confederate states left the Union, their citizens were no longer U.S. citizens.

Time to remove the Confederate statue

I recently had to go to the Gregg County Courthouse. It is difficult to visit the courthouse without encountering the monolithic statue to a Confederate soldier on its lawn.

The monument, "Dedicated to the Confederate soldier of 1861-1865," was erected by the Daughters of the Confederacy on June 3rd, 1911, and was followed in 1921 by a KKK parade in Longview at the height of the Jim Crow South.

On the west side of the base in raised letters is inscribed "Lest We Forget." Lest we forget what? That the Southern states were traitors to the United States of America? That their policies promoted the kidnapping and enslavement of an entire race of human beings resulting in the impoverishment and terrorization of their ancestors until this day?

The presence of the statue on our county courthouse grounds implies an endorsement of the ideas it represents: division, hatred, racism, the Jim Crow South — all things many of us are anxious to see become relics of the past.

I, for one, am tired of living in the dreadful past of the Civil War. It is time to move beyond the conflict and the hate that accompanied it and to look to what we can be as a community forged in love and respect for each other.

- 1. The monument does not represent who our community is anymore.
- 2. No Civil War battle took place in Longview or Gregg County.
- 3. It does not represent history it is an attempt to rewrite history.

I encourage the Gregg County commissioners to take up this issue. The courthouse is a place everyone must go at some time to conduct all manner of business.

The statue does not belong on this public site where all must view it in order to enter. Our region is booming. Our downtown is thriving. Our arts district is the pride of East Texas.

Let us look to the future instead of the past. Remove this statue and find it a new home on private land where those who love it can continue to view it, but it will no longer hurt those with bitter feelings from the dark past of slavery.

J.D. Boydstun: Another view on Gregg County's Confederate monument

Please allow me to respond to Ellen Herbert's essay which appeared in the Saturday Forum of the Longview News-Journal. She describes her extreme dislike of having to walk past the Confederate monument on the Gregg County Courthouse lawn and claims the monument evokes all kinds of negative feelings and memories when she is forced to view it. At the center of it all is the specter of slavery.

I am curious to know how she would feel walking past the Washington Monument in our nation's capital. She must be aware that King George had declared slavery illegal in the colonies and that General Washington was not fighting indirectly or hypothetically against that proposition, but instead was fighting directly for the perpetuation of slavery in the United States.

As a matter of fact, seven of the first nine U.S. presidents were enslavers of men. Why is there no will to remove the Washington Monument, or the Jefferson Memorial, for that matter? Why is the focus solely on all things Confederate? The answer is because it is easy. It is low-hanging fruit. Anyone with half an eye can see the blatant hypocrisy here.

The Gregg County Confederate monument is dedicated to an anonymous Confederate soldier. She must be aware that many Confederate soldiers were conscripts, or draftees. Should not all the hatred and contempt she expressed in her essay be better directed at those who actually volunteered to serve? A statue of Gen. John Gregg would work nicely for that, not an anonymous soldier.

It is not necessary to resort to name calling either, labelling Southerners as "traitors." There was not a single Confederate soldier or politician tried for treason after the war — not one.





Editors Note: Doing some research on Colonel Hoole I discovered there is a collection of letters and notes written by him while fighting in Bleeding Kansas (1856-1857) and later serving in the Confederate Army. The final letter is dated 18 September 1863, shortly before he was killed in action during the Battle of Chickamauga. The collection served as source material for "A Southerner's Viewpoint of the Kansas Situation, 1856-1857," edited by William Stanley Hoole (1903-1990). I don't know the kinship but he is buried in Grove Cemetery in Darlington. It was published in the Kansas Historical Quarterly in 1934. Link to "A Southerner's Viewpoint of the Kansas Situation". 


President Boydstun presented his program about the Battle of Pea Ridge. It was a very informative program the 21 chapter members and three guests thoroughly enjoyed..
